IN 2021, IN ADDITION TO THE EXHIBIT REDESIGN AND CONSTRUCTION PROJECT, THE MUSEUM HOSTED EVENTS AND PROGRAMS IN THE COMMUNITY, INCLUDING VIRTUAL AND OFF-SITE PROGRAMS FOR SCHOOLS AND COMMUNITY ORGANIZATIONS, AS WELL AS EVENTS, PROGRAMS AND SUMMER CAMPS AT A PARTNER LOCATION.

THE MUSEUM'S NAME WAS OFFICIALLY CHANGED TO THE DELAWARE MUSEUM OF NATURE AND SCIENCE IN EARLY 2022. ON MAY 23, 2022, THE MUSEUM REOPENED TO THE PUBLIC WITH ALL NEW EXHIBITS, INCLUDING THE REGIONAL JOURNEY GALLERY, THE ALISON K. BRADFORD GLOBAL JOURNEY GALLERY, THE ELLICE AND
